Herne Farm Leisure Centre Opening Times:

- Monday to Friday: 09:00 till 22:30 (inclusive).
- Saturday & Sunday: 09:00 till 22:30 (inclusive).

Squash Court Hire Periods:

- **Off-Peak** (Mon-Fri) 09:00 am till 12:45 pm.
- **Peak** (Mon-Fri) 12:45 pm till 22:30 pm.
- (Sat-Sun) 09:00 pm till 22:30 pm.

Charges are:

- **Standard Rate** £6.00 (Per Court Session).
- **Standard Court Time** 45 Minutes Only (Per Court Session).

Single Hire:

Fees Per Court

- **Residents Peak** £3.00 (50% resident discount),
(Maximum of two sessions per day).
- **Residents Off-Peak** £1.50 (Maximum of two sessions per day).
- **Non-Resident** £6.00 (Standard Rate),
(Maximum of two sessions per day).

Multiple Hires:

Fees Per Court

- **Squash Court Fees** £6.00 (Standard Rate).
(There is **NO** Resident discount allowed on '**Multiple Hires**').
- **Coaching Court Fees** £6.00 (Standard Rate).
(A Coach or Adult Supervision is required when coaching Under 16's).
- Any '**Hire Period**' that exceeds the '**Standard Court Time**' period(s) will be charged at an extra £2.00 for every 15 minutes thereafter.
- The Completion of the '**Multiple Hire Agreement**' form.
(This must be completed in full, signed and returned to the Centre Manager).

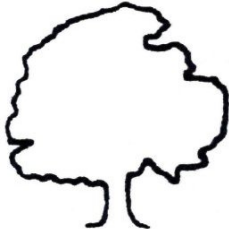
Coaching Hires:

Fees Per Court

- **Court Fees - Basic** £6.00 (Standard Rate).
(One on One only coaching of Adults or Under 16's).
- **Court Fees - Group(s)** £6.00 (Standard Rate).
(Adequate Adult Supervisions required for all Under 16's).

Please Note:

- The Leisure Centre is manned between **09:00 till 13:00 Monday to Friday**, the CCTV records **24/7** and is monitored and checked on a regular basis.
- Organised '**Tournaments**' are **not permitted** for Health & Safety reasons.
- Restrictions on numbers may also apply on some coaching hires.

Multiple Hire Discounts:

- There is '**No Resident**' discount allowed on '**Multiple Hires**'.
- Any discount is at the Centre Managers discretion, up to a maximum of **10%** and only **one** discount allowed per hire agreement.
(*Dependant on duration, number of courts, age groups and numbers*).

Multiple Hire Deposit:

- A Deposit may be required depending on numbers and circumstances.
(*The deposit amount is at the discretion of the Centre Manager*).
- A Deposit is returnable, providing acceptable completion of the hire.

Multiple Hire Fees:

- All '**Multiple Hires**' are '**Provisional**' until full payment has been received, including any returnable deposit if required.
- All Squash Court Fees to be paid prior to commencement of the Hire.
(*On request the payment can be made within 14 days after the date of the first session to avoid the 10% late payment charge or cancellation of the Hire*).
